TERMS AND CONDITIONS

For School Families...Of the percentage the merchant is paying back to the school; $\frac{1}{2}$ goes directly towards your child's tuition for the next year and the other $\frac{1}{2}$ goes to the school operating budget. Grandparents, other relatives & friends can sign up with your child's name as recipient.

Shop & Earn credits may also be applied towards your children's tuition at St. Francis Borgia Regional High School with the other $\frac{1}{2}$ going to Our Lady of Lourdes School operating budget.

Once a participating member does not have a child at Our Lady of Lourdes School or St. Francis Borgia Regional High School to apply tuition credits to, then all credits will automatically go towards Our Lady of Lourdes School operating budget.

For All Parish Members... If you do not have a child, grandchild, or other relative in Our Lady of Lourdes School or St. Francis Borgia Regional High School, you may choose Option B - total percentage merchants pay will go to Our Lady of Lourdes School operating budget OR you may choose Option C - total percentage to Our Lady of Lourdes St. Bernadette's Purse Tuition Assistance Program.

SCRIP PROGRAM AGENCY AGREEMENT

Lourdes Shop & Earn, Inc. offers a scrip program in which we, as agent, purchase scrip on your behalf. The scrip you purchase through our program generates rebates from the participating retailers. These rebates can be used as a credit to your tuition account and/or a donation to the school and Our Lady of Lourdes Parish. In consideration of your participation in the scrip program and our desire to make your tuition as affordable as possible, we agree as follows:

1. We agree to act as your agent to purchase scrip on your behalf from such retailers and in such quantities as you designate on an initialed Shop & Earn order form.
2. As your agent, we may purchase scrip in advance of your order to be held as inventory at the office. We will only make advance purchases for inventory in such quantities and types as are consistent with our participants' purchase history.
3. We agree to annually apply the balance of your rebates on or before May 31st as designated below (Please choose between Plan A, Plan B or Plan C and insert names and desired percentages, if necessary):

- A. 50% donated to the Our Lady of Lourdes Grade School as a charitable contribution; and 50% credited to the following tuition account(s), allocated among the accounts in accordance with the corresponding percentages:

You agree and acknowledge as follows: (1) no employment or partnership arrangement is created as a result of our agency relationship; (ii) you are the owner of the scrip you purchase; (iii) you have no rights to return the scrip we purchase on your behalf, based on the return policy of our scrip supplier; (iv) you shall indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover the checks or ACH debits you issue to pay for your scrip; and (v) we make no representations or warranties of any kind with respect to the scrip purchased on your behalf.

Schnucks eScrip Program: If you participate in the Schnucks eScrip program, the balance of your rebates will be deposited with Lourdes Shop & Earn, Inc. and will be annually applied to tuition account(s) as designated in this document. If no tuition accounts are denoted, then we will donate 100% of the balance to OLLGS.

This agreement can be terminated by either of us upon 60 days' advance notice to the other with the accumulated balance of your rebates to be credited as designated in this agreement
